Information Sheet for Suppliers

Product Documentation requirements

The provision of the product documents relevant to us in German is one of the foundations of our business relationship. In this leaflet you will find information on the documents required by law (mandatory documents) as well as information on further documents required by FISHBULL. Please note that as a supplier of FISHBULL you are obliged to provide certain documents in accordance with the legal requirements.

We count on your support and ask you to take our requirements into account when providing these documents.

Safety Data Sheet

The obligation to prepare safety data sheets lies with manufacturers, formulators or importers if the article is to be supplied to a downstream user.

FISHBULL is such a so-called downstream user, i.e. there is basically no obligation for FISHBULL to prepare a safety data sheet. Exception: private label products if the product does not state "manufactured for FISHBULL" or similar

A safety data sheet must be prepared for the following products:

Substances or mixtures that are either

- 1. hazardous (according to the CLP Regulation)
- 2. persistent, bioaccumulative and toxic (PBT) or very persistent and very bioaccumulative (vPvB) or
- 3. listed in the candidate list for substances subject to authorization according to Art. 31 I REACH Regulation

The safety data sheet is structured according to a specific scheme. The specifications and a template can be found in Annex 2 of the REACH Regulation. The safety data sheet must be provided to us in German.

Data Sheet for the Public

The manufacturer of detergents and cleaning agents is obliged to make a data sheet available to the public.

Reason: In an emergency, medical personnel must be able to find out the ingredients of a product via the data sheet for the public to be able to react accordingly, e.g. when a child eats a dishwasher tab. Detergents and cleaning agents = Article 2 No. 1 of Regulation (EC) No. 648/2004 substances, mixtures and products

Keywords: detergents, surfactants, soap, washing aids, fabric softeners, cleaning agents, other detergents and cleaning products

Labelling of detergents and surfactants intended for detergents to consumers in § 8 WRMG to the extent specified in Art. 11 II Detergents Regulation

Data Sheet for Medical Personnel

The data sheet for medical personnel differs from all previous data sheets, particularly in terms of length and content. In this version, the product is to be named as well as all ingredients in descending order of quantity compared to content.

According to Art. 9 para. 3 of the Detergents Regulation, the manufacturer of the mixtures to which the Regulation applies is obliged to provide a data sheet for medical personnel immediately and free of charge upon request, in which all ingredients according to Annex VII section C are listed.

EU Declaration of Conformity

With the declaration of conformity, the signatory (manufacturer/authorized representative) declares that the product meets all EU requirements and may be placed on the European internal market without restriction. For a declaration of conformity to be issued, the product must undergo a test procedure and be confirmed by an official body such as TÜV.

The declaration of conformity is often printed directly in the operating instructions or can at least be viewed digitally on the manufacturer's website. It should include:

- Name and full business address (or that of the representative)
- Serial number and model or type designation of the product Declaration of acceptance of responsibility
- Means of tracing the origin of the product
- Details of the body where the conformity assessment procedure was carried out Mention of relevant legislation and harmonized standards
- Date of issue, name and signature

Energy Efficiency Label

The legal basis is Regulation (EU) 2017/369 (labelling of energy-related products).

An energy efficiency label classifies appliances and products according to their energy consumption (A - G). The labelling obligation lies with the manufacturer or importer. The label must be affixed in such a way that it is visible and easy to read when sold in stores or online stores. In addition, the products must be registered in the European Product Database for Energy Labelling (EPREL).

The reason for this is to support the end consumer's sales decision. The labels are intended to let the consumer know what energy consumption is to be expected and how the product/appliance compares to others.

Products without a CE mark may not be offered on the European internal market. Furthermore, it is prohibited to make a product with a CE mark available on the market if it in fact does not meet the required EU standards. As the CE mark is a prerequisite for sale, it may not be used for advertising purposes.

As a testing body, the $T\overline{U}V$ can issue various certificates, such as a certificate of conformity. All certificates can be checked for correctness in the database.

Advertising with a $T\bar{U}V$ seal is only permitted if a corresponding certificate is available A $T\bar{U}V$ seal can also be stated in the advertising.

Blue Angel

The Blue Angel is an environmental label of the German Federal Government. It is intended to guarantee that the product is less harmful to the environment and climate. It takes a holistic view of the product life cycle, i. e. from manufacture and use through to disposal and recycling. The label may only be used if the product has been officially awarded the label. This means that there must be a valid contract for the use of the label, which must be extended by the manufacturer/importer to the retailer.

Registrations

Biocidal products

In accordance with Regulation (EU 528/2012) on the Provision on the market and use of biocidal products biocidal products biocidal products must be authorized and registered with the BAUA (Federal Office for Occupational Safety and Health) with the authorization number received. The BAUA maintains a database in which all important information on the product and the validity of the authorization number can be viewed. Non-authorized biocidal products may not be made available on the market.

The Ordinance on the Notification and Supply of Biocidal Products and on the Implementation of Regulation (EU) No. 528/2012 (Ordinance on the Implementation of Biocidal Products) - ChemBiozidDV - regulates the notification procedure for biocidal products.

Manufacturers or importers of biocidal products made available in Germany must notify the Federal Agency for Chemicals of the annual quantities by 31.03. each year.
